

Special Meeting February 13, 2007.

Audited Financial Statements.

Jurisdictional Itinerary.

Brother Switzer presented his first Jurisdictional Itinerary. Everyone congratulated Terry on his excellent work! Brother Nichols stated that he would include the Jurisdictional Itinerary along with a request for additional activities to be sent to Brother Switzer, in his next mailing to all Lodges and to the Secretaries and Scribes of the other Units of Odd Fellowship in Ontario.

Joint Installation of the Grand Lodge and Rebekah Assembly.

Brother Benson brought forward the idea of holding a Joint, Open Installation of the Officers of the Grand Lodge and Rebekah Assembly of Ontario during the 2008 Lodge year.

The Executive of the Rebekah Assembly has agreed to look into this matter and Sisters Dorothy Lawrence and Dianne Cole have been appointed to discuss this matter. It was moved by Brother Switzer and seconded by Brother Nichols that this Executive support this idea and that our Grand Master appoint two persons to enter into these discussions with a view to having a Joint Installation of Officers in 2008.
