The January 21, 2020, meeting of the Executive of the Grand Lodge of Ontario was called to order at 9:45 am by our Grand Master, Brother Jim Broadfoot. Brother Jim asked Brother John Nichols to give an opening prayer.

4. Minutes of the Last Meeting.

It was properly moved and seconded, that the Minutes of the last meeting, be adopted as printed and circulated, subject to any corrections. **CARRIED.**

5A Audited Financial Statements.

Brother Schwalm presented the Audited Financial Statements for the period ending August 31, 2019.

The Executive reviewed the Statements and found all to be in good order. It was properly moved with second that the Audited Financial Statements be accepted and signed by the appropriate Officers. **CARRIED.**

5B Budget Year to Date.

Brother Bob presented the Budget, year to date and noted that everything is in really good shape at this point. Dues are down somewhat but we still have some Annual Returns to come in.

The Budget is well in hand at this point and will be closely monitored by Brothers Nichols and Schwalm.

It was properly moved and seconded that the Budget reports be approved as presented. **CARRIED.**

5C Proposed Budget.

Brother Schwalm presented the proposed budget for 2020 - 2021. This budget has been reviewed by the Budget Committee and is now before the Executive.

The Executive reviewed the proposed budget and Brother Schwalm answered questions. It was properly moved with second that the

proposed budget, as presented, be approved and forwarded to the Sessional Finance Committee for their work. **CARRIED.**

6A Otter Lodge #50 (In Camera)

This matter was held in Camera due to it being the private business of one Lodge in the Jurisdiction. This matter was left in the hands of Brother Jim Broadfoot, John Nichols and Duncan McMillan.

6B Outstanding Annual and Semi Annual Returns.

Brother Nichols reported on the outstanding annual returns and noted that there was one lodge that was still delinquent on the Semi Annual Return from last year.

It was noted that, as of this time, 23 Annual Returns remain outstanding. Penalties for late returns will be applied as at the end of October.

Numerous emails have been sent to the Lodges that do not have their returns in at this point and Brother Broadfoot has made a couple of calls. The Lodges that we have not received the returns from, at this point, are:

Otter # 50 (in process and we should receive next week)

Aurora #148 (in process and we should receive next week)

Sudbury #282

Athena #306

Brother Nichols reported that the 10% Penalty has been applied and the Lodges notified of the same. It was mentioned that the Penalty needs to be applied sooner to spur Lodges to get their reports in on time and Brother Nichols responded that he will send a letter with next year's returns stating that, allowing a bit of grace for Canada Post, the 10% Penalty will be applied to all Annual Returns not in the Office by October 15.

Brother McMahon will be talking with Athena Lodge #306 and Brother Dopp will speak with Sudbury Lodge #282.

7A Phones and Phone System.

Brother Nichols advised that we have switched our phone service to Wightman Telecom for a variety of reasons. There should be no disruption of service and we should receive better service than we had been receiving.

Brother Nichols also talked about our phone system that is now rather old and obsolete. The phone system is currently still working but we can no longer get parts and service on the system. Wightman does sell phone systems so that may be an option for the future. Brothers Nichols and Schwalm will keep the Executive up to date on the phone system situation.

7B Maple Leaf #57 (In Camera)
